

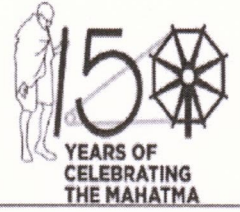

***(In pursuance of power conferred upon Officer on special duty by the Fee Regulatory Committee (Technical) vide its resolution dated 8<sup>th</sup> August 2019, the following circular is issued to declare the fee structures for the year 2019-20)***

### **CIRCULAR:**

For institutions/courses started in the academic year 2019-20 the Committee, after examining the merits of the proposal, has determined the fee structures for the year **2019-20** only as per the Appendix attached herewith.

The fee determined by the committee is applicable to a student who is admitted in that academic year and shall continue to apply till completion of his or her course in the same institution.

The institution shall not charge or collect any fee other than the fee determined by the committee. It is also not allowed to collect the fee at a time amounting to more than one term fee from a student in an academic year.

However, for the fee determination of year 2019-20 of the present fee block, the institutions shall have to submit proposal along with detail audited financial data for the Financial Year 2019-20 latest by **01.06.2020** in prescribed format for further necessary process at committee level.
